## REQUEST

Approve an ordinance to amend the 2026 Budget by recognition of the Department of Local Affairs (“DOLA”) Homelessness Resolution Program (“HRP”) Grant funds in the amount of \$75,000.

## BACKGROUND

This grant will create an amendment to the 2026 budget of the City of Commerce City, Colorado for the recognition of grant funds from the Department of Local Affairs (“DOLA”) Homelessness Resolution Program (“HRP”) grant funds in the amount of \$75,000. The Community Well-Being Team will be providing match funding through an in-kind contribution of staff time to implement the project equal to \$7,440.

The HRP grant funding will be used for street outreach, specifically to expand safe parking efforts, in Adams County.
