- 2025 Summary

FRESH START EVENT

- Event held on 10/02/25 and provided opportunity for defendants with outstanding warrants, fines, or other compliance issues to get cases back on track.
- To continue to be held annually in the future.

Fine Schedule Updates

- Fine Schedule Review and Updates in 2025
 - Traffic and Non-Traffic Fine Schedule amounts increased in 2025
 - First increase to most fines since 2009
 - Overweight vehicle fine schedule amounts increased in January 2026

INDIGENT DEFENSE COUNSEL

- \$35,203.34 paid to Court Appointed Attorneys in 2025
- Grant funds used to pay Court Appointed Attorneys for all qualifying first appearances
 - 46 1st appearances in 2025
 - \$3,300.00 paid from 1st appearance DOLA grant funds in 2025
 - 1st appearance DOLA grant funding discontinued in 2025 as part of State budget cuts; some carryover of funds will be used in 2026, however, City will need to cover the CAA expense for 1st appearances moving forward.

INTERGOVERNMENTAL AGREEMENTS

- Adams County Detention Facility
 - Video appearances of persons in custody –continued to utilize WebEx and Zoom platforms in 2025.

COLORADO MUNICIPAL JUDGE'S ASSOCIATION

- Judicial Conferences –presiding and 1 substitute judge attended Spring and Fall CMJA Conferences in 2025. City covers expenses and membership dues for Presiding Judge.

Colorado Supreme Court Opinion

- **24SA276 In Re: People vs. Camp**
- **24SA308 & 24SA309 In Re: People vs. Simons**

-Applying a preemption analysis, the supreme court holds that when a municipal ordinance and a state statute prohibit identical conduct, the municipal penalties for such conduct may not exceed the corresponding state penalties for that conduct. Accordingly, while an individual may be prosecuted in municipal court for their ordinance violation, they may not be subjected to penalties that exceed the state caps for the corresponding offenses.

- In-person Spanish interpreters available every other Wednesday
- Language Line interpreters used for all other languages and court dates
 - Available for 240+ languages
 - 24 different languages accessed in 2025
 - Top 5 language interpreters used in 2025: Spanish, French, Mandarin, Vietnamese, Russian
- Use of LanguageLine interpreter services has provided additional convenience & significant cost savings
