ORDINANCE NO. 2613

AN ORDINANCE AMENDING THE 2024 BUDGET OF THE CITY OF COMMERCE CITY, COLORADO BY THE RECOGNITION OF COLORADO DEPARTMENT OF TRANSPORTATION FUNDS IN THE AMOUNT OF \$453,600 FOR THE FISCAL YEAR 2025 HIGHWAY SAFETY IMPROVEMENT PROGRAM.

WHEREAS, the City of Commerce City ("City") was awarded a grant in the amount of \$453,600 from the Colorado Department of Transportation ("CDOT") to update the traffic signal detection systems and provide dilemma zone and red protection at 12 signalized intersections;

WHEREAS, Resolution No. 2023-125 was passed on December 4, 2023, by the City Council to authorize an Intergovernmental Agreement ("IGA") between the City and CDOT regarding the funding to install the traffic signal detection improvements;

WHEREAS, the City and CDOT executed the IGA in March 2024;

WHEREAS, this project will improve safety at highly traveled intersections and reduces the amount of red light running during peak hours; and

WHEREAS, the City plans to contribute \$50,400 in funding toward the traffic signal detection improvements.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COMMERCE CITY, COLORADO, AS FOLLOWS:

- **SECTION 1. Findings.** The recitals to this ordinance are incorporated as findings of the City Council. This ordinance is found to be necessary for the preservation of the public health, safety, and welfare and in the public interest.
- **SECTION 2. Authorization.** The 2024 budget of the City of Commerce City, Colorado is amended to recognize this funding from the Colorado Department of Transportation in the amount of \$453,600 and to appropriate such funds in the Capital Expenditures Fund (Fund 395) for a total of \$453,600.
- **SECTION 3. Repealer.** All other ordinances or portions thereof inconsistent or conflicting with this ordinance or any portion hereof are hereby repealed to the extent of such inconsistency.
- **SECTION 4. Effective Date.** This ordinance shall be effective immediately upon passage on second and final reading.
