REQUEST

Consider accepting a donation of a public art piece to the city from the Sand Creek Regional Greenway Partnership for display at the Eagle Pointe Recreation Center. Previously displayed temporarily on greenway property, the piece would become property of the city's public art collection if accepted.

BACKGROUND

The piece, titled "Protecting Commerce", is a sculpture of a bison ingesting common litter items to demonstrate the impact of trash and waste on wildlife, natural spaces, and the overall environment. Curated and created by local students ages 10-15, through trash pick ups and studio time with a professional artist. Installed at Sand Creek Regional Greenway temporarily, and is now being donated to the Commerce City public art collection with a proposed installation site of Eagle Pointe Recreation Center.

The Public Art Master Plan determines that donations must go through the art selection process outlined in the master plan. Sand Creek Regional Greenway followed the process of an art selection committee, who made the recommendation to accept this specific artwork for donation. Cultural Council approved the donation and proposed install at Eagle Pointe Recreation Center on Feb. 18, 2025. City Council makes the final approval to accept the artwork and installation site.

Sand Creek Regional Greenway will handle maintenance for the first two years, with future efforts to be paid out of the Commerce

City public art maintenance budget. (Approved by Facilities Team at Eagle Pointe Recreation Center). Impact is expected to be minimal to none.

Project was funded by Metro Football Stadium District funds and a Quality Community Foundation grant.
